17. Board of Directors: Term

A Director shall be elected for a term of two years and shall be eligible for re-election for additional terms.

One half of the number of Directors shall be directed to hold office for a term of one year from the date of their election or until the first Annual meeting after such date, whichever shall occur first; and one half of the number of Directors shall be directed to hold office for a term of two years from the date of their election or until the second Annual meeting after such date, whichever shall occur first.

At each Annual meeting thereafter, up to ten Directors shall be elected for a term of two years or until the second Annual meeting after their election, whichever shall occur first.

Discussion arising from the minutes included autonomous networks; affiliates calling for better engagement with family networks; website. Questions were asked, answered, and will be incorporated into document for Board to review.

Annual Report – Cindy highlighted the work of Family Alliance Ontario over past 8 months contained in the report which was previously distributed.

Highlights included:

- Proud of the volunteers—commitment of time, energy, knowledge, freely given; kids/loved ones recognize the difference between freely given support and paid support/service
- Acknowledged the strength of Carla's efficiency—Carla has been instrumental in leading the charge in keeping the Board focussed and on direction
- **Monthly meetings –** standard format; increased efficiency
- Meetings of executive- started to determine action and clarity for meetings
- September 2018 Gathering—led to Board planning day bringing people together to work on the direction we received from family network gathering. Work stemming from Board Planning Day
 - Reviewed the accord; determination of the kind of Board wanted to be; created Work Plans; Commitment to Better Family Network engagement; acknowledgement that Policies/Procedures need to evolve as the work continues to effectively guide the work;
- **Process for Affiliation**—criteria created to guide the process
- Governmental Engagement-letters written included
 - Welcome to Premier and request to meet
 - Support for the Child and Youth advocate
- Advocacy Work
 - Bringing awareness of the disparity created by housing allowance increase

- Pie in the Sky advocacy (cost of housing disparity between MPPs and those relying on Social Assistance)
- Remember Every Name highlights importance of maintaining and highlighting Huronia cemetery
 - FAO provided a letter of support
 - commissioned a monument government withholding permission to install;
 - the request has finally been approved
 - Cindy put out a call to families to attend the commemoration ceremony
- Advocacy Package—adaptable by people and networks
 - Thunder Bay did significant work utilizing this package
- Budget Consultation- continue to advocate as we have for individualized direct funding for people and families
- Collaboration with other Provincial Organizations
 - Budget Consultation— continue to advocate as we have for individualized direct funding for people and families
 - Collaboration with other Prov. Organizations
 - SSAH/PC families not receiving notification re funding
 - Engaged using a survey 1330 email permission for report back; initial data was disseminated

New Affiliation

- Accepted new family group P.A.D.D.D. North Bay—a group of parents of children were in the institution; received some network funding which allowed for significant growth
- Received two other application—to be reviewed at next meeting of the Board

Affiliated Network Engagement

- Network engagement—communication is a key thing;
 - started quarterly meetings 1st meeting had 11 participants; provides for sharing; updates on what family networks are doing with the family network funding;
 - Next scheduled meeting –August 9th
- Advocacy package heard loud and clear from family networks were pleased that it could be adapted to their needs
- Uncovering the People's History Project—Chair of Steering Committee gave brief presentation of project and progress to date

Discussion arising from Annual Report included questions/comments about unpaid members; relationships with Transfer Payment Agencies; autonomous groups; Family Network Funding from the Ministry; Facebook pages; policy/procedures; website; follow up with government; Passport Funding; LHIN-Family Managed Health Care; Power of Attorney; silencing informed families. *Questions were asked, answered, and will be incorporated into document for Board to review.*

- Invite family networks to join—Board would be willing to connect with family networks for conversation
- Use of Zoom has proven very useful—a great way to bring resources to family network—suggestion that the Board investigate how to better make use of the forum
